



## ***FACT SHEET*** ***McCullen v. Coakley***

### ***ABOUT McCullen v. Coakley***

On Nov. 13, 2007, Massachusetts Gov. Deval Patrick signed into law S.B. 1353, which created a 35-foot “buffer” zone to restrict pro-life advocates from talking with people entering abortion clinics. Alliance Defending Freedom allied attorney Michael DePrimo together with Alliance Defending Freedom attorneys filed suit in federal court against the new law in 2008 on behalf of pro-life advocates, alleging that the law violated their First Amendment freedoms. De Primo is currently litigating the case together with two other allied attorneys, Philip Moran and Mark Rienzi. Rienzi, professor of constitutional law at Catholic University of America’s Columbus School of Law, is now lead counsel alongside attorneys with the Washington, D.C. firm Wilmer, Cutler, Pickering, Hale & Dorr, LLP.

### ***CURRENT STATUS AS OF 6/26/14***

The U.S. Supreme Court ruled on June 26, 2014 that the law is unconstitutional.

### ***WHAT IS AT STAKE?***

Whether the government can create censorship zones where the First Amendment does not apply in order to silence a particular viewpoint.
